

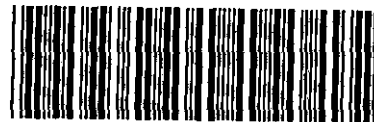

1 Accounting policies

4 Transactions with directors

The company's directors are materially interested as partners of the farming partnership of firm of R B Millar. During the year the company accounted for £300,000 (2007 - £200,500) of profits from its share as a partner in R B Millar partnership. Expenditure during the year of £58,066 was paid by R B Millar partnership on behalf of R B Millar Limited. The company also rents land to the firm of R B Millar and in the year charged a rent of £500 (2007 - £500). Included in debtors is an amount due by the partnership of £542,934 (2007 - £300,000). This balance is interest free and has no fixed terms of repayments. The maximum liability during the year was £542,934.
